- g) Graduation certificate(s) (Master's or equivalent degree)

Further information for applicants:

- a) At least <u>one</u> of the two supervisors <u>must be from the MUK supervisor pool</u>; <u>external supervisors</u> must have a post-doctoral qualification (*Habilitation* or equivalent).
- b) Only completely submitted applications will be accepted.
- c) On the basis of the submitted documents, the doctoral committee will decide whether the applicant will be invited to an admission board examination.
- d) At the admission board examination the applicant must present the concept of the research project (20 minutes maximum). This will be followed by a conversation between the doctoral committee and the applicant (40 minutes maximum).
- e) The doctoral committee will decide on the basis of the submitted documents, the opinions obtained from the supervisors and the decision of the examination board regarding the fulfilment of the admission requirements (a simple majority decision; in the event of a tie, the chairperson of the doctoral committee will decide).

With this Supervision Agreement, the student to be supervised undertakes to:

- comply with all regulations as stipulated in the official rules and policies of the university (Articles of Association of the University, Curriculum, study regulations, etc.);
- make every effort to complete the dissertation project within the standard six-semester period of study;
- reliably comply with all agreements made with the supervisors (deadlines, timetable, work steps, work packages, etc.) and consider these binding;
- regularly consult with the supervisors on the progress of the dissertation project, agree on the next work steps and notify the supervisors in a timely manner of any delays or interruptions;
- inform the supervisors and the head of the doctoral studies programme without delay of any decision to discontinue or change the topic of the dissertation project or to discontinue doctoral studies.

Termination of the Supervision Agreement:

Until the submission of the dissertation project, the Supervision Agreement may be terminated at any time subject to the approval of the doctoral committee.

In the event of breaches of the obligations stipulated in the Supervision Agreement, the head of the doctoral studies programme or the Director of Studies is to be contacted.
